Horizon Europe Framework Programme "European Research Council (ERC)", "Health", "Widening Participation and Strengthening the European Research Area" Information Day

The event was focused on providing information and guidance to researchers and academics on the funding opportunities available under the Horizon Europe Framework Programme, specifically in the areas of the European Research Council, Health, and WIDERA. The event featured presentations and information sessions by Bülent Özcan, the Director-General for Financial Cooperation and Project Implementation at the Ministry of Foreign Affairs Directorate for EU Affairs, and experts from TÜBİTAK, including Özge Gözay and Derya Dönertaş.



The sessions provided detailed information on the specific calls within these areas and allowed for opportunities for questions and discussion, as well as networking with industry professionals and experts in the field. 
In the webinar, the call documents and guidelines on how to apply for the call will be presented. ERA4Health will also facilitate the networking of applicants. Link

#### Finnish and French cities chart Europe's path to clean energy

As Europe strives to become the first climateneutral continent by 2050, Turku and Dijon are among a group of cities seeking to reach this goal two decades earlier.

In 2029, Finland's oldest city, Turku, will celebrate reaching the grand old age of 800. At the same time, it hopes to reach another major milestone – becoming climate-neutral. The French city of Dijon 2 000 kilometres away hopes to achieve the same goal by 2030. The two are part of the Cities Mission – an EU initiative to create 100 climate-neutral cities by the end of this decade. Link

#### Public health: more time to certify medical devices to mitigate risks of shortages

The new medical devices Regulation (2017/745/ EU) (MDR) and the in vitro diagnostic medical devices Regulation (2017/746/EU) (IVDR) bring EU legislation into line with technical advances, changes in medical science, and progress in law-making. The new Regulations create a robust, transparent, and sustainable regulatory framework, recognised internationally, that improves clinical safety and creates fair market access for manufacturers.Link

On January 6th, the Commission adopted a proposal to give more time to certify medical devices to mitigate the risk of shortages. The proposal introduces a longer transition period to adapt to new rules, as foreseen under the Medical Devices Regulation. The new deadlines depend on the medical devices' risk class and will ensure continued access to medical devices for patients. It will also allow medical devices placed on the market in accordance with the current legal framework and that are still available to remain on the market Link





From mental health to medical devices: a lookahead into 2023

Since the COVID pandemic, the European Commission has presented a steady stream of health files to answer the many health issues in the EU and globally, work that is expected to continue in 2023.

2022 was pretty generous in terms of the EU's health policy, particularly regarding the European health union puzzle pieces which finally came into place. This important framework covers severe, cross-border health threats and provides new skins for the European Centre for Disease Prevention and Control (ECDC) and the European Medicines Agency (EMA), and extra powers to the European Health Emergency Preparedness and Response Authority (HERA). The Commission is expected to address the topic of mental health next year, with a strategy pencilled in the second quarter of 2023, as was announced in von der Leyen's SOTEU speech in mid-September. # Brussels kicks off push to improve working conditions and career paths for young researchers across Europe

Without action, the quality of research could decline, research commissioner Mariya Gabriel is told as she announces pilot to be launched in 2024 in partnership with member states and industry. The EU is to pilot a new initiative that aims to improve working conditions for young researchers, starting in 2024. The pilot will test how the European Commission, member states and industry could work together to coordinate financing and knowledge networks and strengthen and diversify research career paths by promoting links between academia and industry. #### European markets start New Year on high note

European stock markets started the New Year on a high note after a tumultuous 2022, with International Monetary Fund (IMF) chief Kristalina Georgieva warning that a third of the global economy faces a recession in 2023. Inflation, fuelled by surging food and energy prices, but European gas prices, which had climbed to a record €345 in March, fell to €73 at the beginning of 2023 – its lowest level since the war started. # Education and healthcare are set for a high-tech boost

The enhancement of human-machine interaction is expected to bring big improvements in support for learning and access to healthcare.

Rapid improvements in intuitive humanmachine interactions (HMI) are poised to kick off big changes in society. In particular, two European research projects give a sense of how these trends could influence two core areas: education and healthcare.

The Parliament's credibility took a battering in December when Belgian authorities launched a probe into current and former MEPs accused of taking bribes in exchange for favors from Qatar and Morocco.

In the EU-funded PhilHumans project that he is coordinating, early-stage researchers from five universities across Europe work with two commercial partners, to learn how innovative technologies can improve people's health. As a starting point, the team produced an algorithm able to respond with the appropriate tone and content to convey empathy. The technology has yet to be converted into an app or product but provides a building block that could be used in many different applications. Link
